Item 9. Other Events

At the Regular Meeting of the Board of Directors of NOW Corporation held on 12 March 2014, the Board ratified the company's subscription to additional shares of i-Resource Consulting International, Inc. in the amount of Eleven Million Pesos (Php11,000,000.00) equivalent to 110,000 shares. Of the said subscription, the amount of Three Million Pesos (PhP3,000,000.00) has been paid in cash.

The board approved the delegation to the Chairman, or in his absence the Vice-Chairman, and to the President, the authority to approve the 2013 audited financial statements of the company.

In view of the company's annual stockholders' meeting scheduled on 5 June 2014, the board resolved to set the record date on 30 April 2014.

Lastly, the board appointed Mr. Vicente I. Peñanueva as Acting Chief Financial Officer of the company.
