Clarification of News Report

"TWO small telcos NOW Corp. and G.Telecom, are forming their respective consortium in preparation for the bidding for the slot of a third major telecom player.

Kristian Pura, NOW's Business Development head, said the company will definitely join the government bidding for the third player.

'We will participate, definitely. That's for sure, either in a consortium, and we're open to forming a consortium of local telcos. And then three, we will wait for the TOR (terms of reference),' Pura said in (sic) an interview at the sidelines of the Department of Information and Communications Technology's (DICT) preliminary conference on the selection process for the new major player.

Currently, NOW is in talks with foreign and local firms.

'There are several groups who already reached out to us, NOW Corp. So we're engaging with them now. We're finalizing some details,' Pura said
