In an ambitious stride towards enhanced national connectivity, NOW Telecom Company, Inc., an associate of NOW Corporation, announced the successful renewal of its radio station licenses within the coveted 3.5 GHz spectrum by the National Telecommunications Commission (NTC) in January 2024.

This pivotal move marks NOW Telecom's proactive efforts to augment its telecommunications network across the Philippines. This license renewal heralds a pivotal chapter for NOW Telecom, symbolizing a committed effort to mitigate the digital divide, with a keen focus on elevating connectivity in public and private, including residential, and particularly, in previously unserved and underserved locales. As a reminder, NOW Telecom is distinguished as one of only four entities awarded a licensed mobile telecommunications system (MTS) by the NTC, a group that includes esteemed operators Smart, Globe, and Dito. The original MTS license, granted in 2006, is "not specific to 3G," thus, encompassing technologies beyond 3G — such as 5G, 6G, and satellite to mobile phone communications — underpins the company's capability to leverage emerging technologies.

The reaffirmed license is set to accelerate the deployment of broadband services across multiple sectors, emphasizing the vital role of connectivity within critical infrastructure. NOW Telecom is committed to constructing secure, dependable, and resilient communication networks, built upon trusted technology, and is dedicated to bolstering the 16 critical infrastructure sectors as delineated by both Philippine agencies and the U.S. Department of Homeland Security.
